

# Organic Certification Cost Share Program

---

The Organic Cost-Share program, which reimburses certified organic producers and handlers for the expense of certification, is now available for 2019! You can receive 75% of your annual certification costs (up to \$750 per scope certified) paid for between 10/01/2018 – 09/30/2019. New operations must await certification prior to applying.
